Notice to Skippers No. 16/2023

Pursuant to Art. 14 sec. 1 point 4 of the Act of 20 July 2017 Water Law (consolidated text Dz.U. /Journal of Laws/ of 2022, item 2625) and Art. 43 sec. 6 of the Act of 21 December 2000 on Inland Navigation (consolidated text Dz.U. /Journal of Laws/ of 2022, item 1097 and 2642 as amended), the Regional Water Management Board in Białystok of the State Water Holding "Polish Waters" announces that:

the current fairway depth on the Narew River waterway between 83+500 and 248+500 km

(from the mouth of the Orzyc River to the mouth of the Pisa River) is 30 cm.

Due to the shallow fairway depth, it is recommended to execute extreme caution during the navigation.
