### Navigation Message no. 5/2021

Pursuant to Art. 14 sec. 1 point 4 of the Act of 20 July 2017 Water Law (Dz. U. /Journal of Laws/ of 2021 item 624) and Art. 43 sec. 6 of the Act of 21 December 2000 on inland waterway (Dz. U. /Journal Of Laws/ of 2019, item 1568 as amended), the Regional Water Management Board in Białystok of the State Water Holding "Polish Waters" announces that:

## as for 27 April 2021, the waterway of Great Masurian Lakes is going to be opened, including:

- lakes: Ros, Seksta, Śniardwy, Mikołajskie, Tałty, Tałtowisko, Kotek, Szymon, Szymonieckie, Jagodne, Boczne, Niegocin, Tajty, Kisajno, Dargin, Kirsajty, Mamry;
- · rivers and canals connecting the above mentioned lakes between the towns of Pisz and Węgorzewo;
- distributary channel of the Pisz Węgorzewo waterway running through lakes:
  - Mikołajskie Bełdany Guzianka Mała Guzianka Wielka Nidzkie (up to 3 km, constituting the border with the Nidzkie Lake nature conservation area (Rezerwat przyrody "Jezioro Nidzkie") together with the Nidzki Canal;
  - o Tałty Ryńskie;
  - o Niegocin Tajty Kisajno together with Niegocin Canal and Piękna Góra Canal
  - Mamry Święcajty

## Opening of the waterway will include the following minimum waterway depth for safe navigation:

The given minimum waterway depth for safe navigation refer to average water level - the reading at the gauge in Giżycko was 119 cm.

The above-mentioned trails are not suitable for night-time sailing.

# Navigational difficulties:

- Jegliński Canal (km 2+000 6+000) temporary waterway signs are in use due to repairs of shoreline reinforcement;
- Łuczański Canal (Giżycki) (km 61+420 61+500) temporary waterway signs are in use in the
  area of the south inlet (Dalba port area in Giżycko) due to the redevelopment of the quay of
  Lake Niegocin. Waterways of Dalba and City Water Sports Centre's (Miejska Baza Sportów
  Wodnych) port are closed.
- · construction works aiming at rebuilding and reinforcing the following canals are underway:
- Tałcki Canal at km 33+000 34+600 of the Pisz Węgorzewo main trail
- Grunwaldzki Canal at km 36+100 36+570 of the Pisz Węgorzewo main trail
- Mioduński Canal at km 37+050 38+970 of the Pisz Węgorzewo main trail
- Szymoński Canal at km 40+340 42+700 of the Pisz Węgorzewo main trail

The canals are also subject to temporary waterway traffic arrangements, which may cause some disruption and prolonged passage times through the canals. However, the waterway users must strictly observe the installed waterway signs and instructions of the operator.

Details of how the waterway traffic arrangements on each of the canals to be repaired will be specified in separate messages.

#### Swing bridge on the Łuczański Canal in Giżycko

We would also like to report that as of 1 May 2021, the Dangerous Weather Phenomena Signalling System is going to be activated in the area of the Great Masurian Lakes.

Additionally, the Masurian Voluntary Water Rescue Service is going to mark the most dangerous places of the Great Masurian Lake System that located beyond the area of the waterway.
