## Notice to Skippers No. 13/2021.

Pursuant to Art. 14 sec. 1 point 4 of the Act of 20 July 2017 Water Law (consolidated text Dz.U./Journal of Laws/ of 2021, item 624) and Art. 43 sec. 6 of the Act of 21 December 2000, on inland navigation (consolidated text: Dz.U./Journal of Laws/ of 2019, item 1568) Regional Water Management Board in Białystok would like to announce that:

as of 22 June this year, at km 150+457 of the Narew River waterway (Ostrołęka) only the 20 m wide section, from the right bank, remains clear. The passage of sailing units along the remaining section (40 m from the left bank) is prohibited due to the raised damming weir flap.

<u>Please limit the speed to 5 km/h, exercise extreme caution in the area of the weir, and follow the navigation signs, with no exceptions.</u>

Further information on existing difficulties along the indicated section of the Narew River waterway shall be provided in subsequent Notices to Skippers.
